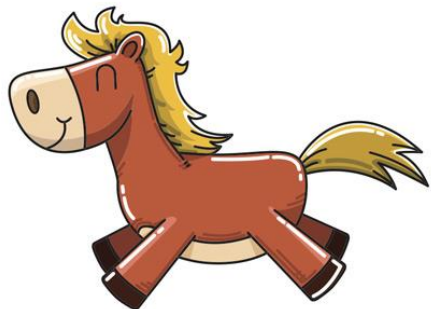

CGA requests that it's members wear approved safety helmets. If you choose not to wear a safety helmet, then you as an adult rider will accept full responsibility for yourself for any injury which may result from that act when riding in any CGA sanctioned show. Effective March 1, 2003, all riders under 18 are REQUIRED to wear a helmet when riding at a CGA sanctioned show. CGA DOES NOT PROVIDE MEDICAL INSURANCE FOR ITS MEMBERS!
