Entries after July 1<sup>st</sup>, 2024 must be processed in person at State Show and will be assessed an onsite processing fee of \$25 per entry. Onsite entries can be paid by cash, check or credit card.  
**NOTE:** If a check is returned unpaid (bounced), the rider will be assessed a \$25 returned item fee and any awards can be withheld until payment is received.
