Meeting Minutes- Submitted by Brittney Fontyn CGA Secretary

1. Opening and Introductory Comments- Meeting was opened by Nathan Rowles, CGA President at 9:03 am. Nathan Explained that due to the lengthy agenda speakers will be limited to 3minutes, and if the need to get back up to speak again they will be limited to 1 minute to keep the meeting moving.

(New Business)

a. Submitted By Timmi Lemen- As a rider and a judge, I've witnessed and experienced myself, my belt getting hung up on the horn. Although half belts are an option. I find them expensive and lacking to cover whatever our rule is that feels we should wear belts. Again, trying to stay current with the times, yet keep professionalism in our sport, I'd like to eliminate mandatory belt requirements and make it optional.

The current section 3.1 paragraph 2 of our rule book currently reads,

Clothing shall be neat and clean. All contestants shall be fully attired in a dress shirt with a button or snap (functional or non-functional) in the front from top to bottom and a collar. Long pants, belt or 1/2 belt and boots. The shirt may have a front or back zipper. If the shirt has a front zipper, it must be covered by non-functional button or snaps from top to bottom. Shirts must be tucked into pants. Only the top 2 buttons of the shirt may be left unbuttoned as long as the buttons go to the collar line of the shirt. A tie or neckerchief is not required but is encouraged.

I propose the following change.

Clothing shall be neat and clean. All contestants shall be fully attired in a dress shirt with a button or snap (functional or non-functional) in the front from top to bottom and a collar. Long pants, and boots. The shirt may have a front or back zipper. If the shirt has a front zipper, it must be covered by non-functional buttons or snaps from top to bottom. Shirts must be tucked into pants. Only the top 2 buttons of the shirt may be left unbuttoned as long as the buttons go to the collar line of the shirt. A belt or 1/2 belt, neckerchiefs or tie is not required, but is encouraged. - **Seconded by Diana Malley, After discussion, Passed**

- b. Submitted by Lorelei Lehman- to clarify a lead line rule. The Rule currently reads as follows:2.3 Special "Lead Line" Rules for Riders who need assistance

The CGA is interested in providing an opportunity for riders who need assistance to participate in CGA Shows. For this reason, the following special rules shall be applied at CGA Shows that allow participation of these riders:

A: A rider may be led through the course by a parent or responsible party and an additional assistant (if needed), provided the rider is not able to complete the course without assistance. Such assistance is allowed to ensure the safety of the rider but does not extend to the assistant(s) touching the poles, flags or other obstacles. The Lead Line Team (Horse, rider, leader and additional assistant) must properly complete the course. The assistant(s) must conform to the same dress code defined for judges (See Section 6.1).

B:Hard hats are mandatory for all Lead Liners riders. The animal being led shall be in normal tack with the addition of a halter and lead rope.

C:Lead Line riders may NOT participate in the Hurry Scurry event for safety reasons.

D: A mount may NOT be entered in the same event more than once except as a Lead Line Entry.

E: Lead Line riders may proceed no faster than a trot or they will be disqualified.

F. When Leading the animal across the timing line, the assistant must be at or behind the shoulder of the animal to prevent any timer malfunctions.

I would like to change 2.3 F to read:

"When Leading the animal across the timing line, the assistant should be at or behind the shoulder of the animal to prevent any timer malfunctions. If timer malfunctions due to the position of the leader, then a no time can be given.- **Seconded by Bob Lyon- After discussion and amending motion failed**

- c. Submitted By Rachel Trani- motion to change section 4.3 of the rulebook to read as follows

Rule book section 4.3

A rider may be assisted in the arena in a safe manner. Physically pushing the horse from behind is not allowed, and any other act considered unsafe may result in a disqualification.

Currently it reads: a rider may be assisted in the arena, I believe it needs to be clarified further.- **seconded by Jennifer Roberts, after discussion motion failed**

- d. Submitted By Amy Odom-Tollison-Motion to add the following sentence to the end of 4.1 (c)

Intentionally setting a course 6 inches shorter to benefit a rider is considered cheating and can result in disciplinary action.

Currently the rule reads:

Resetting the course and raking: After each run, course obstacles should be reset to their original position so that the course will be as identical as possible for each contestant. The course should be raked around each obstacle if required for the safety of the contestants. A contestant has the right to request resetting and/or raking of the course. Any course may be off by a total of six (6) inches from its' prescribed dimensions and still be considered a legal course when re-checked- **Seconded by Timmi Lemen after discussion motion failed**

e. Submitted by Shannon Cannon- Current: 3.5 Pony Size and Certification Process To qualify an animal to compete in a CGA Pony Division at a State Sponsored Show or for CGA State Year End Awards the animal must measure 13.2 hands or fifty-four (54") inches or less without shoes. An additional one-quarter (1/4") inch is allowed when a pony is shod. The measurement is taken using a CGA provided rigid measuring stick that has a leveler built into the horizontal arm. Ponies that are fifty-two (52") inches or less may be measured by a Master Judge and a Senior Judge. Ponies that are over fifty-two (52") inches must be measured by two (2) Master Judges. Certification expires at the conclusion of the current season. All annual certificates must be submitted to the CGA State Office by the certifying Master Judge(s). A copy should be given to the member for their records. Certificates are supplied to the Master Judges by CGA State Office. You may ask for a measurement for informational purposes (not a pony certificate) one time per season to verify if you need trimming, shoes or a calmer time for your pony. You ask for the Information and Certificate measurement at the same measuring session, so long as the pony does not leave the measuring area or the visual range of the Master Judge(s) doing the measuring. The final decision to certify an animal as a CGA Pony lies with the Master Judges(s) measuring the animal. The Master Judges Advisory Committee reserves the right to require a pony to be remeasured if a majority feels that circumstances have changed since the certification was granted.- **Seconded by Lorelai Lehman, After discussion motion Failed**

g. Submitted By Lorelie Lehman- From the rule book I would like to change the following paragraph to add the sentence that is highlighted in red.

Section 6: Gymkhana Judges

6.1 Requirements to Become a CGA Judge Approved CGA shows must be judged by licensed CGA gymkhana judges. The judge must be physically in the arena during each and every rider's run. Apprentice judges must have a licensed judge in the arena with them at all times they are judging an event. Any CGA member may apply to become an apprentice judge at 16 years of age or an official CGA judge at 18 years of age. They must complete the entire process within 18 months of getting their apprentice card. If they fail to do so, the apprenticeship is cancelled and the candidate must start over from the beginning. **If the**

apprentice judge takes the written test and passes and takes the arena test and is told by the Master Judge that they need more time to refine their skills, then the apprentice Judge will be granted a 6 month extension to retake the arena test and the Master Judge will set an agreed upon date for the new arena test. An apprentice may not start judging or taking tests until the apprentice card is received from the CGA State Office.- **Second by, Lorelai Lehman, after discussion Motion Failed**

h. Submitted By Jeni Thompson- 4.7 Leave the Arena- The rider is requested to acknowledge the judge after bringing his/her horse under control. The rider should watch for the judge's signal to leave the arena before walking the horse from the arena. The rider should not dismount at any time while in the arena without permission of the judge. However, if the rider dismounts for reason of safety or reasons beyond their control, the judge's permission to dismount is implied.

4.7 Leave the Arena- The rider may leave the arena once his/her horse is under control and after the judge calls the ride either a) a good ride, b) a good ride with penalties, c) a no time. The rider should not dismount at any time while in the arena without permission of the judge. However, if the rider dismounts for reason of safety or reasons beyond their control, the judge's permission to dismount is implied. - **Second by Shannon Cannon, After Discussion and amendment to the withdraw original proposed, and to just strike the sentence "The rider should watch for the judge's signal to leave the arena before walking the horse from the arena" in 4.7 .motion Passed**

If it is held in or near Bakersfield, no shows may be run within a 200-mile radius on the same weekend. Districts located greater than 100 miles from a CGA Classic event may run set-up shows on Classic weekend.

Here is the proposed change: 'Management experience - A CGA Master Judge candidate shall have served in a management capacity at the District and preferably at the State Level. At the State Level, this includes serving in some management capacity at Jamboree, Northern or Southern Spring Classic, or State Show. At a District level, this includes being a club officer or show manager.'

10.5 Judge

It is the primary purpose of a CGA Judge is to ensure that the competition in the arena is fair and safe for all riders.

The Judge has total control of the activities in the arena. The Judge generally knows more about the rules and the CGA procedures than most other individuals. All Judges MUST be a fully carded CGA Judge. The Judges decisions are final. Judges should keep up to date on all approved changes in the rules that are not currently published in the CGA Rules Book. An apprentice judge must judge under the direct supervision of a carded judge. The judge must stand in the arena at all times while judging. It is impossible to properly judge a show without giving continuous and full attention to all activities going on within the arena. **-Second by Shannon Cannon, Failed**

v. Submitted By Shannon Cannon- Current: 11.4. G. Accompanied by either another Master judge or Senior judge, measure any pony who falls within 4" of the height requirement to give final certification as to whether or not it qualifies as a pony.

w. Submitted By Shannon Cannon- 11.5 Criteria to Become a Master Judge

Current: 11.5.4. Experience - A CGA Master Judge candidate shall have been a CGA member for at least 5 years, and an active carded CGA Judge in good standing for at least 3 years (longer is preferred). 'Active' means that they currently judge CGA shows on a regular basis, both in their local district and in other districts. They shall have judged at the CGA State show for at least two years. They shall be acknowledged by their peers and riders as being fair, impartial and an adherent of the rules.

Proposed: 11.5.4. Experience - A CGA Master Judge candidate shall have been an active carded CGA Judge in good standing for at least 3 years (longer is preferred). 'Active' means that they currently judge CGA shows on a regular basis, both in their local district and in other districts. They shall have judged at a

CGA State show. They shall be acknowledged by their peers and riders as being fair, impartial and an adherent of the rules. **-Second By Brittney Fontyn, Passed**

x. Submitted By Shannon Cannon- 11.6 Nomination Procedure to Become a Master Judge

Current: 11.6.1 The Board of Governors and the MAC must agree that there is a need for an additional Master Judge in a specific geographic area.

Proposed: 11.6.1 A person from any District management, Board of Governors or the MAC can identify a proposed “need” and then the Board of Governors and the MAC must agree that the proposed need is valid for an additional Master Judge in a specific geographic area. A valid “need” is defined as a District whose current Master Judge assigned is not available to the arena in question, already manages more than 1 arena, and/or the arena assigned to Master Judge more 50 miles of home District the Master Judge is a CGA member of.- **Second, Lorelai Lehman, Passed**

y. Submitted By Shanonn Cannon- Current: 11.6.2 The MAC will then survey the area for potential candidates, based on the above criteria. NOTE: First priority will be given to active Senior Judges in the area.

11.x.1 General - A CGA Master Judge candidate is an individual who continues to uphold the highest standard of the CGA. They continue to demonstrated history of supporting CGA and its programs. They are very knowledgeable in the structure and history of the organization, the bylaws, the rules, and the intent behind the rules. They are able to provide correct answers to any question about any aspect of CGA.

11.x.2 CGA commitment - A CGA Master Judge continues to demonstrated a commitment to the CGA. The candidate shall be willing to travel to support CGA’s programs.

11.x.3 Experience - A CGA Master Judge is an active carded CGA Judge in good standing. ‘Active’ means that they currently judge CGA shows on a “regular basis”, both in their local district and in other districts.

They shall be acknowledged by their peers and riders as being fair, impartial and an adherent of the rules.
NOTE: "Regular basis" to maintain active is considered at least 1 show a year.

11.x.4 Character - A CGA Master shall continue to be generally regarded by the CGA membership as diplomatic, tactful, impartial, ethical, open to suggestions and appear to have good decision-making skills. They shall continue to demonstrate an ability to make 'hard' decisions, even when those decisions are unpopular.-**Second Bob Lyon, Passed**

11.7.4 A person from any District management, Board of Governors or the MAC can identify that a Master Judge is not meeting the criteria to maintain "active" Master Judge status. The Board of Governors shall conduct additional interviews as needed, and then confirmation or denial of removal of "Active" Master Judge status with a 2/3 vote from the Board of Governors. - **Second Bob Cranor, Passed**

cc. Submitted By Jeni Thompson- 11.8 Senior Judge Currently Reads

A Senior Judge is recognized by the Master Judge for his or her area as having the potential to become a Master Judge. They have broad knowledge and experience regarding CGA, its rules and the organization in general. A Master Judge may appoint a Senior Judge to help him or her with the duties of a Master Judge as a first step in training them to become a Master Judge in the future. Senior Judges are appointed by the Master Judge for their area, and have responsibility and authority only in the district(s) they are assigned to. While a Senior Judge may be assigned to more than one district, no district may have more than one Senior Judge.

11.8 Senior Judge

Any member that has been a judge for two years and is in good standing may request a level 2 judge's test. Upon passing the level 2 test they will become a Senior judge and work closely with the Master Judge in their area. Senior Judges have responsibility and authority only in the district(s) they are assigned to. A Senior Judge may be assigned to more than one district. - **Second Shannon Cannon, Passed**

3.3 CGA Rating System

CGA has adopted five (5) rating divisions, separating the riders by speed ability. The FC (Future Champion) rating is the easiest rating to acquire, with A, AA, AAA and AAA+

ratings progressively harder to achieve. The times associated with these ratings are given in the CGA Divisional Rating Matrix. (See Appendix 'A')

The CGA Divisional Rating System places a rider/mount combination in a "Division" according to the speed in which they run the 13 different events. (see Appendix "A' CGA Divisional Rating Matrix)

These Divisions are:

*FC (Future Champion)

* Lead Line (LL), same as Future Champion

* A

* AA

* AAA

* AAA+

Page 11 of 11 "Rating" means that the rider/mount combination has a certain number of successful rides within the 13 events.

For instance, a rider must run an event successfully at least three (3) times in the FC or Lead Line division in four (4) different events for that rider/mount combination to be "Rated" FC or LL if they are riding Lead Line To be "Rated" is as follows.

A rider/mount combination must run an event successfully at least three (3) times in the required number of different events to be rated in that Division. See below.

Division	# of events needed
FC/LL	4
A	6
AA	8
AAA	10
AAA+	12

During the CGA season, if a rider/mount combination starts riding in a slower division and is successfully achieving times in a faster division they will automatically be bumped up into that division once they meet the required number of events needed to achieve the faster division.

At the start of a new CGA season all "Ratings" are reset to "not rated". As the show season progresses, current standings can change and may be obtained at any time by going onto the CGA web site under "Reports. General Ratings" or by email tocgastate@aol.co, and requesting your "rating report".
